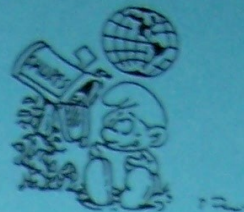

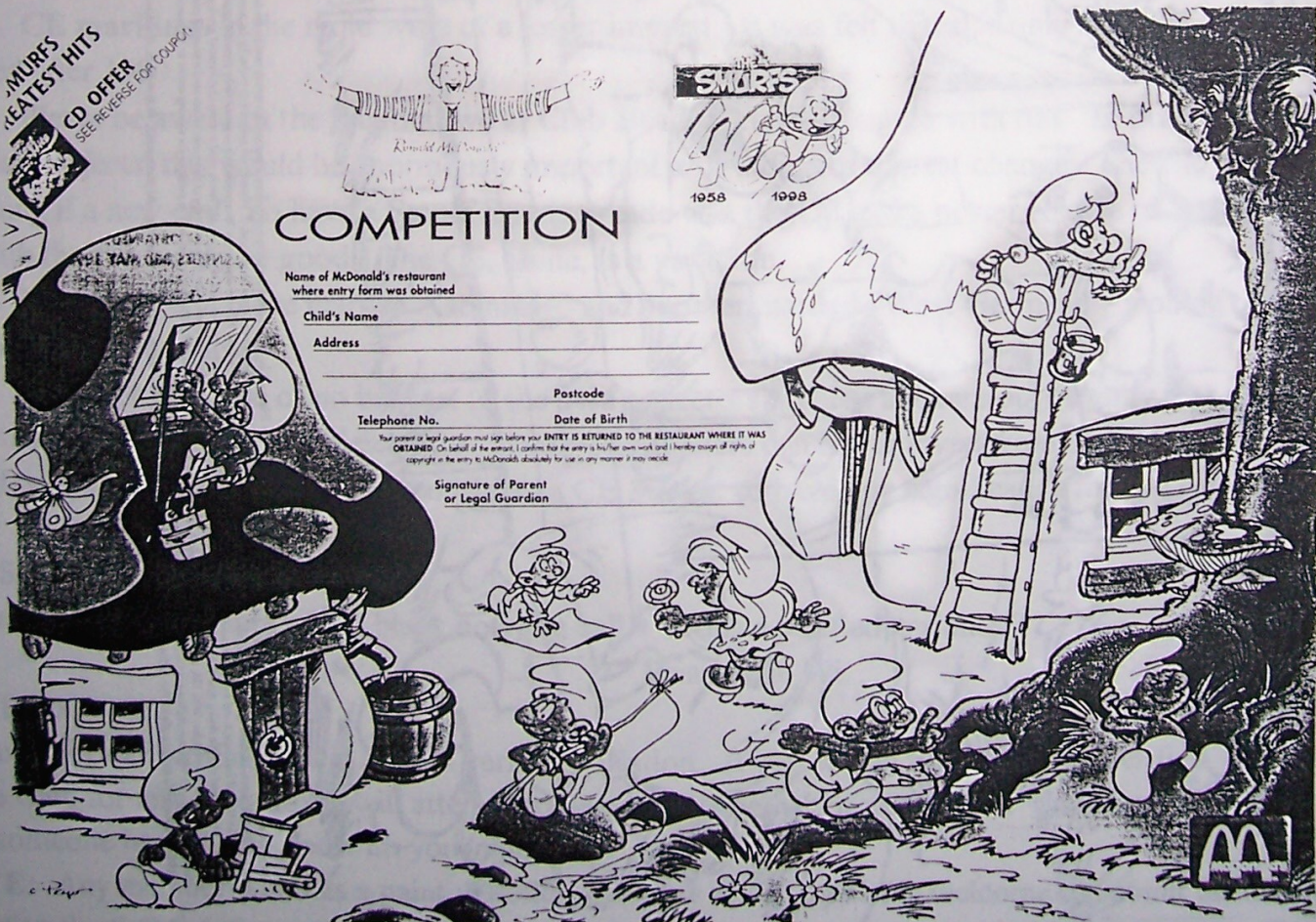

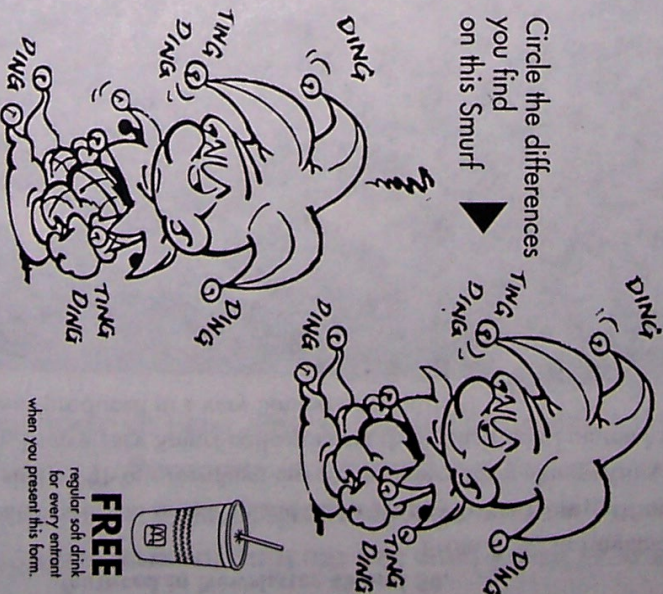

Collectors' Comments.....

Dear Suzanne,

Recovering from illness this past year I have had the time to reread all of the Club's past Newsletters. Wow!!!! There sure is an amazing amount of collectors information packed into our back-issue Newsletters.

I do need some questions answered at this point in my collecting. I have finally completed my basic Composite Set of Smurf figurines Super Smurfs etc. I truly want to thank the Club and all it's members who have been a tremendous help in this effort!

I am now deciding on how to expand my collection. I know there are some wonderful paint variations which is my number one priority to start collecting.

I would like to know how important are Country Markings, Paint dots, and the newer CE markings that I read about in our Newsletters.

Thanks for any advice you can give me at this point in time.

Dear Liz and all members,

A few years back we did a survey asking some of our avid collectors their opinions on the subject matters you refer to. The results were all comparatively the same. Here are the conclusions:

Country Markings are of utmost importance for collecting mold and paint variations.

Country Painted In (Paint dots) These were also voted important for paint variations. A very strong interest was shown in figurines painted in Portugal (gold paint dot). In this case, a very distinctive blue matte finish was used on most of the figurines.

CE markings in the mold were of a lesser interest. It was felt that this only signifies that figurines were injected after 1990.

Please be aware of the fact that we at Club Headquarters, disagree with this. In other collectibles such as porcelain objects, this would be enormously important as it indicates a great change; The end if an era and beginning if a new era! To have a Smurf figurine made w/o the CE and a newer release or version of the **same** one with the CE would be good! The CE, alone, is a variation.

For instance, a piece marked "Germany" and another marked "West Germany" wouldn't one consider these important markings?

CE Stickers were of no interest to the avid collectors! These stickers only signify that they were imported or exported from Schleich after 1990. The stickers can be removed from figurines very easily and placed on another figurine. No one considers a CE Sticker to have any significance for our collections

Dear Suzanne,

I have a Bowler Smurf with a black bowling ball. Is this a verified variation?

Dear Brian,

No, as of this writing, this is NOT a verified variation. If you would like to have it verified, you may submit it to the Club for inspection. We will attempt to determine whether or not it has a "legit" paint job. Let's make sure someone hasn't tampered with your figurine!

NOTE: Any member who has a paint variation that they are unsure of is welcome to submit his/her doubtful Smurf to the S.C.C.I. for a checkup. Any "NEW" paint variation must be verified before it will be listed as a True Paint Variation done by the factory!

Update: This figurine has been received at the Club for verification. Unfortunately, it was found that, under

the black paint the bowling ball was RED!!!!!! Someone had taken a paint brush to this figurine to give it a new look.

Dear Suzanne,

I have a question that I do not see asked or mentioned in our Newsletters. Previously I have read that there is a rare "Bully" mold Gargamel Smurf. This is the Gargamel from the Super Smurf Gargamel and Azrael. The figurine that has Gargamel pointing upward with one finger of his right hand. He does not have the lab. glass in this hand. Wouldn't this mean that there should be a small Azrael mold with the Bully marking?. I do not see Azrael on the Club's listing of Bully figurines. In short if there is a Bully Gargamel why isn't there a Bully Azrael even if he is not a major mold variation?

This is an excellent question!! Bully produced Gargamel as a single figurine, they never produced Super Smurfs. Azrael was not considered a main character by Bully at the time.

I just got the New Pez from Europe along with a delightful store sticker featuring the Smurf Pez. These stickers are in store windows overseas.

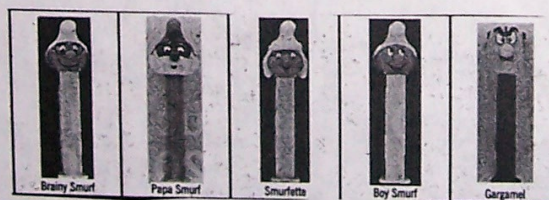


Background is green. It is a cloud-shaped sticker with a peel-off adhesive backing. It measures 11 1/2" by 9 1/2."

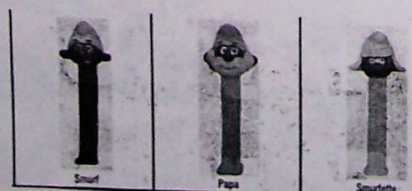

Fristi, the popular soft drink manufacturer in Holland and Belgium, once again, sponsored the event and featured below is a paper sun visor given out for the event.



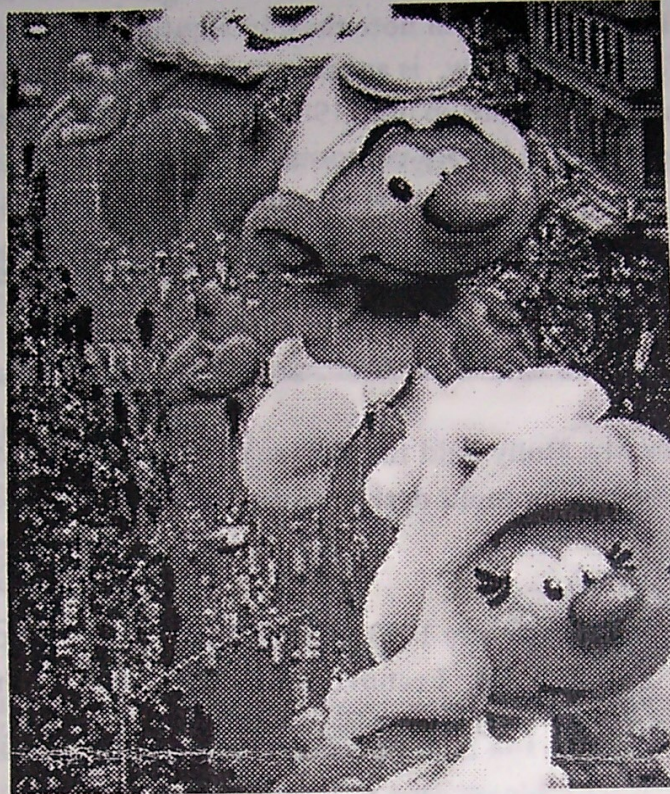
Also produced by Fristi is the Sasette Promotional Magnet and the gliding Puzzle/Keychain featured below.



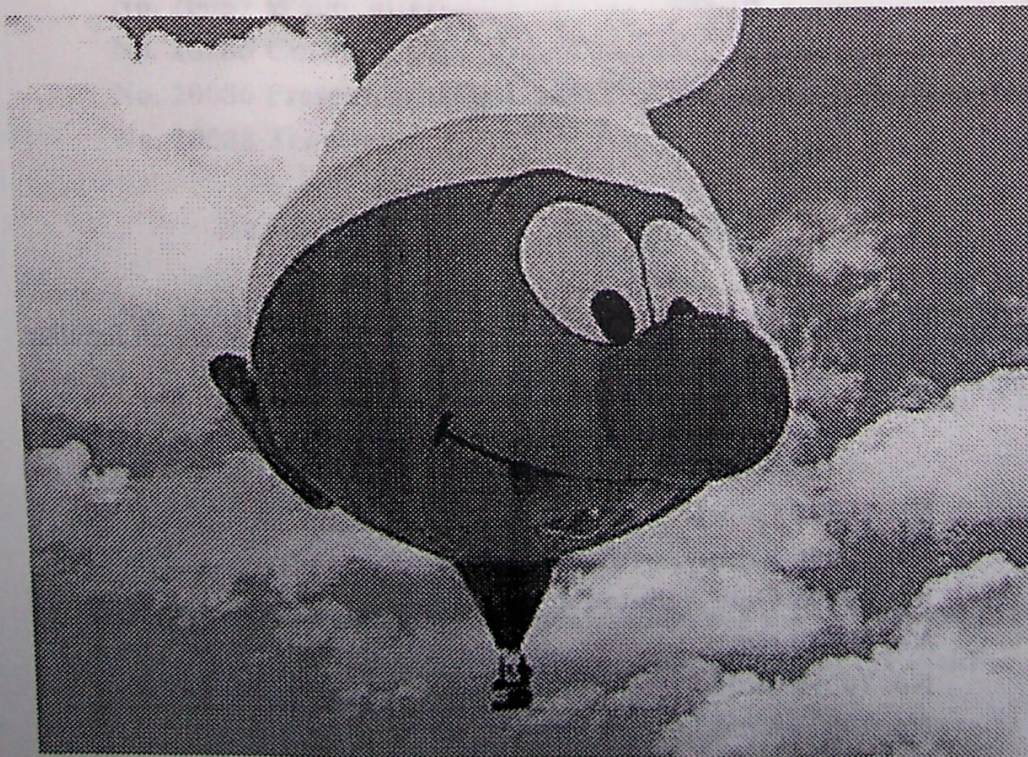

BULLY SMURF FIGURINE DOCUMENTATION FROM THE BULLYWORLD MUSEUM

Jane Klaus, the Executive Vice President of Bullyland Inc., has been kind enough to document all of the Smurf figurines ever produced by the Bully factory. This information has been of tremendous help to us in answering some of our questions that have come up over the years. We would now like to share this information in detail with you, our S.C.C.I. members.

As this information is not included in our new feature section **SMURF PRODUCTION HISTORY** please use it as the **BULLY Production History**. You will note that, in some instances, issue dates differ from the **Schleich dates**. The issue dates information, below, is as presented to us by Bully. We have also been told that each figurine was produced by Bully from it's issue date up until 1980. For example a figurine produced in 1973 would have been produced as follows for Bully production history purposes:

As we have discussed previously, Bully held the license to produce Smurf figurines from 1973 until 1980. A number of Bully figurines were unique in mold design and paint colors. We will attempt to cover all of this information in this article.

The first Smurf to be created by Bully in July 1973 was the Smurf Doctor known to us, using Schleich's complete numbering system, as No. 20075 Quack. Featured below is the drawing that "Peyo" submitted to Bully for this figurine. The figurine was then sculpted by Bully's in-house artist, Irmingard Heiber.



Once again we will be using the Schleich numbering system with which we are all familiar. We will also note descriptions and paint variations that were **unique to the Bully figurine**.

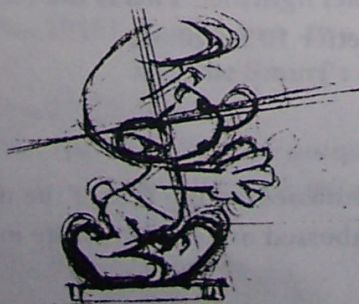

Also, in 1975, Bully developed the first Smurf board game see Newsletter 36 for photo.

These tiny one-inch Bully Sleepwalker Smurf figurines were produced as board pieces for this game. Featured below are "Peyo's" renderings for the board pieces. These tiny 1" Smurfs were produced in different colors as well. The board pieces were only produced in solid black and solid blue with different color round bases. Tiny little black and white bees were also used as board pieces for this game.

It has now been documented that, in 1984, Bully did produce the Waldbaur Candy Promotion solid-color Smurf figurines. This appears to be the one-and-only Smurf promotion they produced. The 1984 date is after they held the license to produce Smurf figurines. Perhaps this is the reason the figurines were produced in different solid colors. We are positive Bully did have "Peyo's" permission to produce these figurines, as the Waldbaur Candy promotion was a licensed promotion (refer to Newsletter 14).

For those members who have our previously issued "BULLY TRADEMARK" list, please use this list in its place. There are a few changes.
